











(annual % change)






**Indicators deflated by consumer prices**




### Current account balance




#### Direct investment account





### France's international investment position












### Overnight deposits

(annual growth rate)






### Deposits up to 2 years




#### Loans to households

(EUR billions)




#### Loans to non-financial corporations

(EUR billions)




#### Consumer loans to households (excl. overdrafts)




### Investment flows







(EUR billions)











(NES 16 Classification, number of companies, non-seasonally adjusted)






### Company failures – year-on-year change




**Market share developments






### Market share developments for each financial centre




**Monthly change in amounts exchanged in French payment systems (a)**

(EUR billions, daily average)




**Monthly change in collateral (b)**
